## **Alzheimer's /dementia disease**

Today throughout the world the elders are affected by Alzheimer's /Dementia without any discrimination. People rich or poor, educated or uneducated this disease affects all kinds of people.

### **7 Stages of dementia**

#### ***Stage 1 No impairment***

There are no symptoms of cognitive impairment, mental function is normal.

#### ***Stage 2 Very mild cognitive declines***

This stage can vary between typical age-related memory problems that most seniors face. Some of side effects that related with the stage include forgetting everyday phrases. Forgetting the location of important objects.

#### ***Stage 3 Mild cognitive declines***

In this stage we can identify the symptoms of dementia or Alzheimer's can become more noticeable to friends and family. The symptoms like impaired work performance, memory loss, verbal repetition, Poor organisation and concentration, trouble with complex tasks and problem-solving difficulty driving.

#### ***Stage 4 Moderate cognitive decline***

This stage is commonly defined as early onset Alzheimer's or dementia. Symptoms of cognitive decline are apparent and your loved one should be seeing a healthcare personal. Signs at this stage include social withdrawal, moodiness and non-responsive.

## **Stage 5**

### **Moderately severe cognitive decline.**

When the elder likely to need help with routine tasks like dressing or bathing, requiring a home care giver and other symptoms include confusion memory loss of personal details and current events, reduced mental acuity and problem solving.

### **Stage 6: Severe cognitive decline**

At this stage elders need help for activities of daily living such as using of bathroom or eating. In this stage elders may experience difficulty in sleeping, increased delusions, anxiety and difficulty to identify the loved ones.

### **Stage 7 Very severe cognitive decline**

This stage is called as late stage dementia. The elders unable to care for themselves, lives with severe motor communication impairment and may lose the ability to speak or walk.
